

Website Registration Quick Reference Guide

This guide will walk you through the steps required to register as a first time user on the Pacific Life website





Step 1: Login or Register to Login

If you had a login setup for the previous quoting webpage, you will be able to use the same user name and password. For instructions on how to setup Multi-Factor Authentication, go to **Step 4**.

For new users, click "Register Here".





Step 2: Complete Registration Form

After clicking on "Register Here", you will be taken to a registration form. Please complete the form with accurate information and click "Submit".


You will receive an email confirming your registration.

Step 3: Complete Account Setup

Once your registration is completed, you will receive an email welcoming you to Pacific Life and a subsequent email with a link to set your account password.



In the second email, click on the "Set password" link in the blue box to setup your password.




After clicking "Set password", you will be prompted to set up your password. Once the password is set up, you will be given a link that brings you back to the login page.



Your password must contain:

- · At least 8 characters
- · At least 3 of the following:
 - · Lower case letters (a-z)
 - · Upper case letters (A-Z)
 - Numbers (0-9)
 - · Special characters (e.g. !@#\$%^&*)
- No more than 2 identical characters in a row





Step 4: Set up Multi-Factor Authentication (MFA)

On the login page, sign in with the email address from your registration and use the password you set up.

Choose the MFA option you prefer

- Authenticator app
- SMS (text message)







Authenticator App

- You may use any authenticator app (Google Authenticator, Microsoft Authenticator, Authy, etc.).
- Scan the QR code provided with the authenticator app of your choosing and then enter the one-time code provided.


• Input phone number to receive the one-time code via text message.
